Invitation to Bid
FOR THE INSTALLATION OF 250MM (10") – 7,664.00
LM TRANSMISSION LINE

1. The Metro Bangued Water District through its *Corporate Budget for CY 2021* for the improvement of its water supply system,³ intends to apply the sum of **Sixty Five Million Pesos (P65,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Installation of 250mm (10") – 7,664.00 LM Transmission Line**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Metro Bangued Water District now invites bids for the **Installation of 250mm (10") – 7,664.00 LM Transmission Line**. Completion of the Works is required for **Two Hundred Sixty Five (265)** calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the Metro Bangued Water District Office and inspect the Bidding Documents at the address given below from *8:00AM – 12:00NN & 1:00PM – 5:00PM*
5. A complete set of Bidding Documents may be acquired by interested bidders on *November 26, 2020 to December 17, 2020* from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty Five Thousand Pesos (P 25,000.00)**.


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Metro Bangued Water District - BAC will hold a Pre-Bid Conference⁴ on *December 4, 2020 at MBWD Office, cor. Taft & Actividad Economia Sts., Zone 4, Bangued, Abra* which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *December 17, 2020 at 2:00PM*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *December 17, 2020 at 2:00PM at MBWD Office, cor. Taft & Actividad Economia Sts., Zone 4, Bangued, Abra*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. This bidding shall be subject to the LWUA's Three Strike Policy Guidelines embodied in LWUA Memorandum Circular No. 006.15, dated 10 June 2015. For more information regarding the said Three Strike Policy Guidelines, please visit the LWUA website, www.lwua.gov.ph.
9. The Metro Bangued Water District reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
