## CONTRACT AGREEMENT

THIS AGREEMENT, made this 25<sup>th</sup> day of *January*, 2021 between **METRO BANGUED WATER DISTRICT**, Corner Taft & Actividad-Economia Sts., Zone 4, Bangued, Abra and MEP CONSTRUCTION #18 ST. Benedict, Petersville Subd. Camp 7, Baguio City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute DRILLING OF 200.00 METERS EXPLORATORY/ PRODUCTION WELL with Solicitation No. 20-12-005 (hereinafter called "the Works") and the Entity has accepted the bid for **FOUR MILLION SEVEN HUNDRED FIFTY-FIVE THOUSAND SEVEN HUNDRED FORTY PESOS (Php 4,755,740.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (h) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Notice of Award of Contract and the Bidder's conforme thereto;
  - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Contract and remedy any defects therein in conformity with the provisions of this Contract in all respects.
