INVITATION TO BID FOR PROCUREMENT OF ½" WATER METER W/ 2 TAILPIECES

1. The **Metro Bangued Water District** through the *Corporate Budget for 2021* intends to apply the sum of *One Million One Hundred Seventy Thousand Pesos (Php 1,170,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *PR No. 21-09-002 Supply and Delivery of 600 PCS ½" WATER METER W/ 2 TAILPIECES*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **METRO BANGUED WATER DISTRICT** now invites bids for **600 PCS. ½" WATER METER W/ 2 TAILPIECES**.³ Delivery of the Goods is required *90 days after receipt of Purchase Order and/or NTP if a contract is signed*. Bidders should have completed, within *7 days after receipt of notice* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Interested bidders may obtain further information from *METRO BANGUED WATER DISTRICT* and inspect the Bidding Documents at the address given below during *8:00AM to 5:00 PM*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *September 16, 2021* from the address below *{Insert if necessary: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIVE THOUSAND PESOS (Php 5,000.00)}*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *METRO BANGUED WATER DISTRICT* will hold a Pre-Bid Conference⁴ on *September 27, 2021- 2:00 pm* at *Cor. Taft & Activiad Economia Sts., Zone 4, Bangued, Abra* which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *2:00 pm- October 14, 2021* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.


