**INVITATION TO BID FOR THE PROCUREMENT OF
FITTINGS FOR MAINTENANCE REPAIR OF
DISTRIBUTION, SERVICE LINES AND NEW SERVICE
CONNECTIONS, ETC.**

1. The **Metro Bangued Water District** through the Government of the Philippines (GOP) under the **Corporate Budget for the Contract Approved by the Board 2025** intends to apply the sum of **One Million Eight Hundred Forty Nine Thousand Six Hundred Pesos Only (PhP1,849,600.00)** being the ABC to payments under the contract for **PROCUREMENT OF FITTINGS FOR MAINTENANCE OF DISTRIBUTION, SERVICE LINES AND NEW SERVICE CONNECTIONS, ETC..** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Metro Bangued Water District now invites bids for the above Procurement Project. **Delivery of the Goods is required by thirty (30) calendar days from effective date of contract.** Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
4. Prospective Bidders may obtain further information from *Metro Bangued Water District BAC Secretariat at Telephone No. (074) 614-6268* and inspect the Bidding Documents at the address given below from **Monday to Friday 8:00AM to 5:00PM.**
5. A complete set of Bidding Documents may be acquired by interested Bidders on **March 25, 2025** from the given address below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five thousand pesos (5,000.00)** to the MBWD cashier.
6. The Metro Bangued Water District will hold a **Pre-Bid Conference¹ on April 3, 2025** at MBWD office Cor. Taft and Actividad Economia sts., Zone 4 Bangued, Abra, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below **on or before 2:00pm on April 15, 2025.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14.**

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference.

9. **Bid opening shall be on April 15, 2025 at 2:00PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The Metro Bangued Water District reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
